TO AVOID A DISRUPTION IN SERVICE, all customers must ensure they can connect to the new DekafLOW DNS name and IP address prior to June 10th, 2022.

ACTION REQUIRED:

1) Copy and paste the new URL address (DEKAFLOW.BHEGTS.COM) into your browser and start DekafLOW by clicking either the Upgrade DekafLOW Access or Customer Activities link (click on the link you normally use) to start DekafLOW.

NOTE: Continue to use the current address (dekaflow.dominionenergy.com) until the transition is complete on June 11th. DEKAFLOW.BHEGTS.COM is the future version of DekafLOW.

2) After DekafLOW has started, please sign into DekafLOW using your existing credentials.
If your DekafLOW account is Revoked or you have forgotten your password, no other actions are necessary.
Note: The initial password in this system originated from your DekafLOW production password.
However, these passwords are not kept in sync.

3) Upon a successful login, you will see the following DekafLOW welcome message at the bottom of the screen:
"Welcome - You have successfully communicated to our BHE GT&S DekafLOW System. We plan on transitioning from Dominion Energy to BHE on June 10, 2022, starting at 10:15PM (CST) through June 11, 2022, at 11:00AM (CST)."

4) No other actions are needed after one of the following:
a) Successful login and receiving the welcome message.
b) Successfully accessing the login screen and the account is Revoked, or password is forgotten.

If these steps are not successful, please contact your IT group with this information to ensure DekafLOW is allowed to be accessed.
